Distance Signage	10 meter and 3 meter circles around all baskets	
OB and Hazard Marking	Visible posts/flags; additional lines preferred for visual reference	
Toilets	At least two near Tee #1 and at least 6 additional on the course located at least on 3 different holes, at least 2 approximately midway through the course, all reserved for official participants only	
Water/food supply	At least three (3) water stations evenly distributed on the course, sufficient water supply in case of extreme heat	
EDGF Visibility	Part of Event and Branding Style Guide which is part of the EDGF Event Manual (online)	

Facilities and Services

Tournament Center	Within walking distance from the course, at least one room with a capacity at least 20 persons	
Official Participants Gathering Area	Sufficiently large area with eventual other amenities must be provided for official participants for gathering on the event	Required and essential at each course: a rainproof area with sufficient seating for players before and after their round.
Parking	Sufficient parking space for the players and their teams in the walking distance to the tournament center (or a centralized parking lot with provided shuttle)	
Warm-up Areas	Required: sufficiently long driving range (up to 150 meters) or a driving area with nets allowing simultaneous driving practice for two-three (2-3) players throwing at the same time; at least four (4) practice putting baskets, the same type of the baskets as the tournament baskets with enough space between them located within three (3) minutes walking from the tee pad of Hole #1 (not interfering with any of the holes)	
Food Services	Lunch menu available during flexible hours (10:30 - 16:00) within walking distance	
Accommodation Services	Sufficient accommodation facilities should be available to meet the expected demand of registered event participants and staff within the vicinity of the event site (no more than a 20-minute drive).	
Event Site Access	The event site should be accessible at least for 60 minutes before the start of the tee-times during all competition days and tee-timed practice days until the sunset or 22:00 (whichever happens first) during the singles competition days and tee-timed practice days.

Opening Ceremony Awards	The LOC is required to host official Opening and Closing/Award Ceremonies. Both ceremonies must be conducted according to EDGF Event Protocol	
Social Events	The LOC is required to host a “Player’s Party” on Saturday evening for all tournament players, substitute players, team captains, and tournament staff, with optional access for team staff.	
EDGF Meetings	The LOC should provide meeting space and limited refreshments for EDGF official meetings	
Limitations	The LOC should communicate all eventual limitations to EDGF in a timely manner, and provide all available information at the time in the limitation questionnaire that is a part of the bidding package	
Minor Guardians Access Rights	Minor guardians registered as team members shall be granted the same access privileges as the player they accompany throughout the event.

Media Plan	Required as a part of the bid proposal	
Media Rights	The LOC and EDGF media rights are described in details in Section S - Rights of these standards and are a part of the contract of the LOC and EDGF	
Local Event Visibility	The event must be visible (e.g. posters, banners, billboards) in the hosting city/town/area for the public awareness	
Media Publishing	The LOC should designate hashtags and other types of identification used by the LOC, EDGF and third parties for presentation of all media content.	
Event Website	Should be available as early as possible after the bid allocation, no later than 12 months before the start of the event. EDGF can provide domain and hosting space, as well as template (https://2027.edgc.eu or https://2027.emdgc.eu)	
Event Graphics	Setting and use is regulated by the EDGF Event & Branding Style Guide.	
Social Media	Setting and use is regulated by the EDGF Event & Branding Style Guide.
