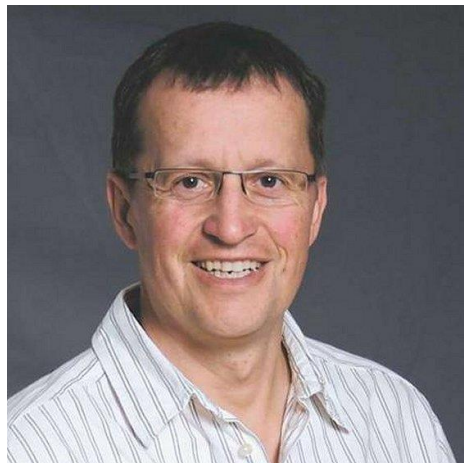

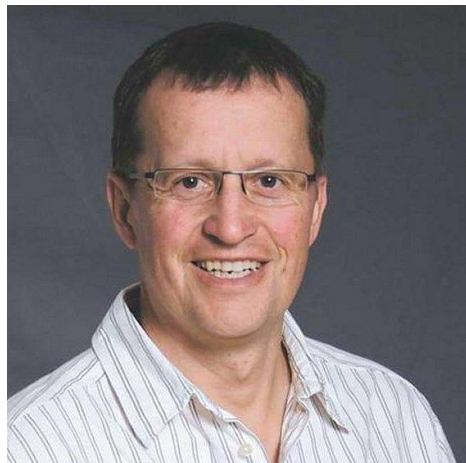

# AUDITOR REPORT



I have audited the accounts of the European Disc Golf Federation (Raiffeisenbank and PayPal) from 2025 with closing as at 30 September 2025. With expenses of CHF 15'379.00 (€16'619.22) and income of CHF 15'268.72 (€ 16'501.22), the fiscal year close with a loss of **CHF -110.28** or **Euro -118.00**.

Including the transitory bookings of CHF 3'575.51 (€ 3'826.00) as income, and transitory liabilities of CHF 2'336.33 (€ 2'500.00), the total assets of EDGF by 30.09.2025 are **CHF 5'561.86** or **Euro 5'951.50**.

**CHF 4'036.25** (equal to Euro 4'319.01) and **Euro 188.49** (equal to CHF 176.15) will be forwarded to the books 2026.

The balances shown in the balance sheet agree with the supporting documents. The vouchers for the entries checked by random sampling are in order. The bookkeeping is very clean and correct.

I propose that the General Assembly approve the accounts 2025 in their present form and grant discharge to the General Secretary, Paul Franzc and the Board of Directors. The Board of Directors is responsible for the annual accounts and it is my task to audit them.

I confirm that I meet the requirements regarding competence and independence.

## EVENT LOGO

### Key Advantages

- **Enhances brand recognition and memorability:** A unique logo makes the event instantly recognizable and ensures it remains memorable for attendees long after the event.
- **Boosts credibility and professionalism:** A polished logo signals a well-organized and legitimate event, which can increase interest and trust from both attendees and sponsors.
- **Supports consistent branding:** A unique logo provides a central point of visual consistency across all event materials, from websites and social media to signage and merchandise. The logo does not have to be re-created every second year.

## EVENT LOGO

### Design Principles

- **Simplicity & Memorability:** Easily recognizable at a glance.
- **Versatility:** Works in one color, on different backgrounds, and across various sizes.
- **Relevance:** Captures the sport's energy.
- **Timelessness:** Avoid fleeting trends for long-term appeal.

## EVENT LOGO



The symbol expresses a throwing motion (rotation), starting slow and ending strong looked from top. It also symbolizes somehow also an eye, an important element of disc golf – focus on the target.

The EDGF logo completes the event logo optimal.
